- 1) I am over 18 and can enter into legally binding contracts under applicable law.
- 2) By signing and submitting this form, I authorize a B representative to place bids on my behalf for the item(s) on this Proxy Bid Form up to and including the amount on the reverse side of this form.
- 3) I understand that this representative will place bids at the increments set by the auctioneer at the live auction.
- 4) I understand that I can only submit proxy bids for live auction items as identified on the website https://bgcsca.ejoinme.org/gala21.
- 5) By signing this Proxy Bid Form, I agree to purchase the item(s) listed above for the amount(s) listed above if I submit the winning bid. If my proxy bid is the highest made at the auction on October 2, 2021, I will win the item and I authorize my credit card above to be charged in that amount.
- 6) I understand that I will receive an e-mail confirmation of my winning bid to the e-mail address stated on this form, no later than the day before the event.
- 7) I understand that my winning item certificate will be mailed to me by regular US postal service or delivered to the above address within two weeks after the Auction, unless I am notified within that same timeframe that the item(s) will be available for pick-up 1304 Calle Valle, San Clemente, CA 92672. For the items that will be mailed, I understand that alternative shipping arrangements can be made at my request after I am notified of my winning bid. I further understand that I may be charged for these alternative shipping arrangements.
- 8) I understand that in the event that two proxy bids tie for the same item, the proxy bidder who submitted their proxy bid form first will win the item.
